

NOTICE OF INTENTION TO DESIGNATE 8 INDIVIDUAL PROPERTIES WITHIN THE TOWN OF AURORA

TAKE NOTICE THAT the Council of The Corporation of the Town of Aurora intends to designate the following 8 individual properties for their Cultural Heritage Value or Interest pursuant to the provisions of Section 29 of the Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended, which was resolved by the Council of The Corporation of the Town of Aurora on June 25, 2024:

The Town's Heritage Advisory Committee was also consulted, including through the meeting held on July 31, 2023, and further information respecting the notice of intention to designate process as well as detailed descriptions on each property's heritage value is available by contacting Town staff at the information below.

Notice of objection to the notice of intention to designate any of the properties listed above may be served on the Clerk of the Town of Aurora within 30 days after the date of original publication in this newspaper (until August 31, 2024). This notice of objection must set out the reason for objection and all relevant facts. If a notice of objection is received, the Council of the Town of Aurora shall consider the objection and make a decision whether to withdraw the notice of intention to designate or not within 90 days after the end of the 30-day objection period. If Council decides not to withdraw its intention to designate, a heritage designation bylaw will be passed, and additional notice of passing will be published, which is further followed by a 30-day appeal period when appeals of the designation bylaw may be given to the Ontario Land Tribunal for a hearing and decision.

The proposed designation does not preclude the completion by the owner of normal repairs and restoration or interior works nor does it preclude a future proposal for complementary addition to the subject building.
